Below decks, the Saffier SC 8m Cabin is surprisingly spacious and has everything you need for an extended weekend trip: Double berth forward, two single berths aft and a galley block with cooker and sink. 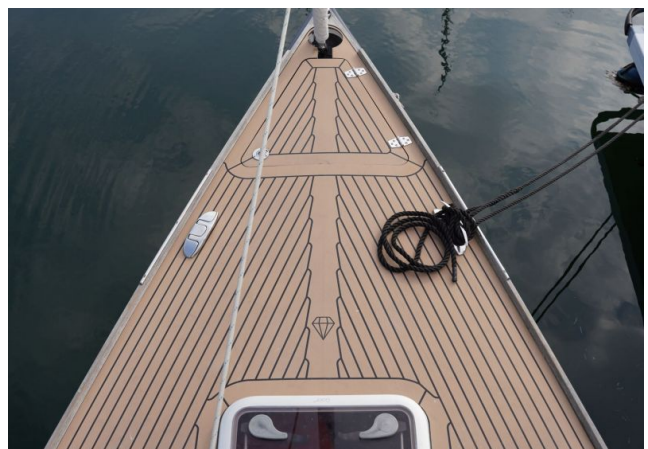
